**RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION
OF RISKS AND INDEMNITY AGREEMENT**

This is a legally binding **Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement** (collectively, "Release"), made voluntarily by me, the undersigned Releasor, on my behalf and on behalf of my heirs, executors, person representatives, legal representatives, assigns, and next of kin to **Sarkine Park/Harley's Catering/Moonwalks and More and the Town of Avon, Indiana**. As the undersigned Releasor, I acknowledge and fully understand that there are dangers and risks to which I may be exposed by participating in **V5 Bungee Trampoline, Hard Rock Wall, Human Gyroscope, Zipline and/or all other Inflatable** activities. These dangers and risks include bodily injury, permanent disability, paralysis and death. These dangers and risks may be caused by my own actions, or inactions, the actions of others participating the **V5 Bungee Trampoline, Hard Rock Wall, Human Gyroscope, Zipline, and/or all other Inflatable** activities, the condition in which the activity takes place, or the negligence of the "Releasees" named below. I understand that participating in **V5 Bungee Trampoline, Hard Rock Wall, Human Gyroscope, Zipline and/or all other Inflatables** while under the influence of alcohol and or drugs is prohibited and I agree that I am not under the influence of alcohol and or drugs. There may be other risks and social and economic losses either not known to me or not readily foreseeable at this time, and I fully accept and assume such risks and all responsibility for losses, costs, and damages I incur as a result of my participating in the activity. By signing this document, I agree that if riding or participating on the following **V5 Bungee Trampoline, Hard Rock Wall, Human Gyroscope, Zipline and/or all other Inflatables**, I weigh between 40 pounds and 245 pounds or I must fit securely in the security harness or vest. I hereby agree that I am in good physical condition and do not have any back, neck, head injuries. It is recommended by the manufacturer of the Mechanical Bull any person(s) with this type of disability or injury should not participate in the **V5 Bungee Trampoline, Hard Rock Wall, Human Gyroscope, Zipline and/or all other Inflatable** activities.

I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless Harley's Catering and Moonwalks and More, its owners, employees, agents, other participants, event sponsors, and if applicable, owners and leasers of the premises on which the activity takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses or damages on my account caused and alleged to be caused in whole or in part by the negligence of the "Releasees", or otherwise.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend to be a complete and unconditional release of all liability to the greatest extent allowed by the law. I further agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
