Application Deadline	Applications for the Plan Commission public hearings must be received at least Fifty-two (52) Days prior to the date of the Plan Commission meeting. **APPOINTMENT REQUIRED FOR SUBMITTAL**
Public/Legal Notification	The Planning Staff is responsible for placing the Public/Legal Notification for the Plan Commission public hearings and will be published in the Hendricks County Republican at least ten (10) days prior to the date of the Plan Commission meeting. Staff will post signs at least 10 days prior.
Written Notification & Sign Posting	The Petitioner is responsible for the Written Notification & Sign Posting. Written Notification to surrounding property owners for Plan Commission public hearings may be sent by first class mail and postmarked at least ten (10) days prior to the date of the Plan Commission meeting. **The signed and notarized affidavits will serve as proof of the Written Notification and a copy of a sample mailing must be filed with the Planning Staff at least seven (7) days prior to the Plan Commission meeting to avoid continuance.**
